The Louisa County Board of Supervisors will hold a public hearing on the following item(s) at 6:00 p.m., after regular business, on Monday, October 3, 2022, in the Public Meeting Room, Main Floor, Louisa County Office Building, 1 Woolfolk Ave., Louisa, Virginia:

<u>Public Hearing – Allocation of Federal Coronavirus Local Fiscal Recovery (SLFRF)</u> <u>Funding from the American Rescue Plan Act (ARPA)</u>

Pursuant to Virginia Code Section 15.2-2507 (A), the Louisa County Board of Supervisors states its intent to amend and adjust the aggregate amount to be appropriated during the current fiscal year in excess of one percent of the total expenditures. Public comment is invited to address consideration of a resolution authorizing a supplemental appropriation of \$3,650,805.50 to the Fiscal Year 2023 budget for the second allocation of Federal Coronavirus Local Fiscal Recovery (SLFRF) funding from the American Rescue Plan Act (ARPA) that the County has received. These funds can be used to (1) respond to the COVID-19 public health emergency or its negative economic impacts (2) respond to workers performing essential work during the COVID-19 public health emergency (3) government services to the extent of County revenue loss due to the COVID-19 health emergency and (4) to make necessary investments in water, sewer, or broadband infrastructure.

<u>Public Hearing – Amendment to Chapter 86 Land Development Regulations – Proposed Addition – South Anna Agricultural and Forestal District</u>

Anthony and Sarah McLoughlin, applicants/owners; request an amendment to Article II. Zoning Ordinance and Maps; Division 7. Agricultural and Forestal Districts of the Louisa County Land Development Regulations (Section 86-501 Districts Described) to amend the South Anna Agricultural and Forestal District to add tax map parcels 56-73 and 56-74, containing a total of 40.71 acres. The subject properties are located on the southeast side of State Route 208 (Courthouse Road), south of State Route 800 (Holly Spring Drive). The property is approximately 0.65 miles from both of the land areas that make up the existing South Anna Agricultural and Forestal District located on the east side of State Route 646 (Yanceyville Road), and the east and west sides of State Route 604 (Roundabout Road), in the Patrick Henry Voting District. The 2040 Louisa County Comprehensive Plan designates this area of Louisa County as Rural Area. The Planning Commission voted to forward a recommendation of approval to the Board of Supervisors at their September 8, 2022, meeting.

- any owner who joined in the application may withdraw his land, in whole or in part, by written notice filed with the local governing body, at any time before the local governing body acts pursuant to § 15.2-4309; and
- additional qualifying lands may be added to an already created district at any time upon separate application pursuant to this chapter;

The district is located in the following general area of Louisa County- on the north and south sides of Route 610 (Holly Grove Drive); and between Route 663 (Owens Creek Road) and Route 664 (Gammon Town Road), in the Mountain Road Voting District. The 2040 Louisa County Comprehensive Plan designates this area of Louisa County as Rural Area. Aura Power Developments (USA), LLC, Applicant; requests an amendment of CUP2021-03, Paragraph# 18, to change the permit deadline that expires on November 22, 2026, to November 22, 2031, to strike language about maximum phase power of power generation within three years, and to provide for extensions.
